The bidders shall submit their e-bid in PPMO'S website **www.bolpatra.gov.np/egp** before *2079/07/14 (2022 OCT 31) 12:00 hrs.* The bids will be opened from the PPMO'S website **www.bolpatra.gov.np/egp** in the presence of Bidders' representatives who choose to attend at **2079/07/14 (2022 OCT 31) 13:00 hrs** at the office of Kanepokhari Rural Municipality, Bayarban, Morang.
5. Bid security must be valid for a period of **90 days as stated below** for after bid opening and must be accompanied by a bid amounting to a minimum of **as specified below** which shall be valid for **30 days beyond the validity period (i.e. 120 days) of the bid after deadline of Bid submission date.**
